1. ABOUT THE INSTITUTE

The Institute Omeo Kumar Das Institute of Social Change and Development (OKDISCD) is an autonomous research institute situated in Guwahati that undertakes, promotes and coordinates research on problems and processes of social transformation and development of Assam and other states of the North Eastern region of India and contributes to the formulation of strategies and programmes for speedier regional development. As envisaged by the founders of the Institute, it acts as a “clearinghouse of ideas and information on research in social sciences with special emphasis on the problems of Assam and other States of the North- Eastern region”.

Established in 1989 under the joint initiative of Government of Assam and Indian Council of Social Science Research (ICSSR) New Delhi, OKDISCD is recognized as a leader in the field of social science research in Northeast India. It is reputed for the quality of its research and various programmes for promoting social sciences and policy research. Over the last more than two and half decades, a large number of studies have been completed by the Institute which has contributed towards the corpus of knowledge on various aspects of social concerns and research priorities in the region. It is noted for its strong research thrust in varied areas of democracy and governance, regional development, health and education, environment, gender, human development that are making substantial contributions to regional and national level. Over the years, the Institute has also created a niche for its innovative courses in capacity development of young scholars of social sciences. It is also the leading Institute in the region in designing and carrying out evaluation and monitoring of various programmes of government agencies, corporate houses and international bodies. The Institute has also emerged as a well-built centre of teaching especially research-oriented courses.

With continuous attempt to achieve new heights in social science research and teaching, the Institute has conducted and initiated several academic activities during the year 2022 – 23.

Situating the Ethnic Communities in the Polity Discourse: A Study of the Mizoram- Myanmar Borderlands

In sync with the research Agenda set in the institute, that underscores North-East India and emerging South-East Asia, the institute has undertaken several projects whose immediate objective is to examine the development of North-East India through the lens of Look (Act) East Policy. This study intends to understand space in the context of borderland areas. The report argues that the Indian state and its agencies and apparatuses aspire to usher in through the Look East Policy a 'place' for the region in the global circuit of capital. The people inhabiting these spaces remain skeptical if not apprehensive about the intentions and ramifications of such statist imaginations. Eventually, it tried to problematize the 'connotations' associated with the trade space of the state and ethnic space of the communities. It also tries to identify the policy measures in terms of actualizing the Look (Act) East Policy in the Mizoram-Myanmar borderland.

The study had found sharp contrast between the existing border trade in NER and container trade that is envisaged in Look (Act) East Policy Documents. The study highlights that for the state trade is purely an international or pan-regional attempt at making economic gains. However, to the borderland communities, trade continues to be petty and informal, and an inter-community (if not intra-community) process of exchange. This not only includes exchange of goods and commodities, but also social and community exchange. This kind of border trade operated through inter/intra-ethnic cooperation.

Life, Livelihood and Exclusion: The Char Dwellers in the Brahmaputra Valley of Assam

Char dwellers of Assam, a population group mostly comprising of Muslims (more than 85 per cent) historically hailing from erstwhile East Bengal (present-day Bangladesh) and who continue to be the worst victims of ubiquitous “indigenous-foreigner-minority” syndrome not only in the Northeastern region but far beyond. Furthermore, the socio-economic conditions of Char areas are strikingly poor in the Brahmaputra valley. In this backdrop, the study tries to discuss the life and livelihood, struggle and adaptation, exclusions and nationality formation of the char dwellers in the Brahmaputra valley of Assam.

The study suggests that the major socio-economic factors related to the poor socio-economic conditions of the char dwellers are not only varied but intertwined too. If geography appears to be the constitutive factor in their isolation, the socio-psychological surroundings also equally contribute to the isolation of char dwellers. With a higher cropping intensity and diversified crop profile, an intersection of structural factors as well as instrumental rigidities debar them from enjoying the fruits of the market ultimately affecting their living and livelihoods. This study also points out that a legislative gap and a jurisprudential hiatus concerning the governance and administration pattern of the impermanent land often add to the precarity of the existence of the char dwellers. The study also observed that migration from a less stable char to a relatively more stable area if not to the mainland is an existential reality of the char dwellers. The study opines that the problems of exclusion and underdevelopment in the study areas are not merely confined to lagging income levels, but also extend to the process of development itself. A bottom-up approach to development planning strategy is required for the char dwellers to uplift their backwardness and deprivation.

Revisiting ‘Khawkhawm: The Application and implication of Village Re-settlement in Mizoram

The research project is the outcome of the deliberative effort of OKD Institute of Social Change and Development to make comprehensive study on the grouping of villages in the present state of Mizoram. As counter-insurgency measures, grouping of villages has a serious impact on the socio-economic life of the people of Mizoram. The impact was not only on the economic and social arena but the psychological impact on the people needs a deeper inquiry in order to understand the distortion created by the institution of the State.

The study finds that the grouped centre had been christened as the centre of development which was a scapegoat for army operation. After the grouping was halted due to the high court intervention and the upgradation of Mizo district to Union Territory, the grouped centres came under the jurisdiction of UT government of Mizoram from the state Govt. of Assam. Eventually, people were allowed and de-restricted to move back to their old villages. This

was also necessary due to economic and social constrain as enough land for jhum cultivation soon become scarce on which almost all the people depended for their livelihood.

Social Review of Disaster Death

The unprecedented rain experienced by Assam during April-May, 2022 caused massive floods across the state and landslides in Dima-Hasao district, leading to the death of 25 people. In view of this catastrophe, the Assam State Disaster Management Authority conceived an idea to do a ‘Social Review of Disaster Deaths’ to explore and investigate personal behaviour of people that might have cause the deaths and family background of the deceased. ASDMA assigned OKD Institute of Social Change and Development, Guwahati to conduct a research based on case studies of the 25 persons died during the disaster. The victims were mainly daily wage earners or engaged in petty business. The educational attainment of the victims was below the level of Higher Secondary except for one. The victims who died due to flood had visibly poor housing conditions that indicated their low level of economic well being. However, the victims affected by landslides had concrete houses but built in hill slopes vulnerable to landslide.

The study reiterated the importance of capacity building among the people in disaster-prone areas to mitigate future disasters through raising awareness and fostering qualitative changes in both individual and societal behaviour. The report also emphasized the need for coordinated efforts among various government departments to mitigate these disasters.

Efficacy of Arundhati Gold Scheme in Assam

The Study ‘Efficacy of Arundhati Gold Scheme in Assam’ was taken up by Omeo Kumar Das Institute of Social Change and Development, Guwahati at the behest of the Office of the Inspector General of Registration, Assam. The study report has made an attempt to understand the effectiveness and usefulness of the Arundhati Gold Scheme launched in Assam in the year 2020.

The report observed that the scheme has been particularly helpful for the economically weaker section of people since the cash benefit has helped the parents to gift their daughters with cash amount for purchase of gold. However, the scheme requires wider publicity so that it can benefit its intended population especially in tea garden areas and minority pockets. The report also suggested revamping the programme by including other options like saving instruments for a fixed tenure of 10 years with any nationalized bank in the name of the married girl which would provide future financial asset to the girl.

Estimation of Gross Fixed Capital Formation in Assam

Estimation of capital formation is an important exercise in preparing national income accounts. The changes and expansion of the economy and economic activities requires fresh estimation of national income statistics taking note of the changes occurring as well as issues related to international comparability. This calls for updating definitions and base year, recognising changing activities, identifying new trends and initiatives. Over the years, several significant changes have taken place in the nature and functioning of the economy. This makes it imperative to examine the existing procedures and practices of estimating national income statistics at the state and district level. The study, therefore, contributed to the preparation of national income statistics by carefully looking at the pertinent issues, particularly, identifying data gaps in estimating Gross Fixed Capital Formation (GFCF) in Assam and developing the methodology for estimation of GFCF for private and household sector for the State of Assam.

Understanding the Problems of Minority Ethnic Communities in Northeast India for Working out the possible solutions

Northeast India is the home to hundreds of ethnic communities existing with myriad diversities of race, culture, language, religious beliefs, and others. The co-existence of

numerous ethnic groups provides significant impetus to the identity and the ethno-cultural milieu of the region. However, ethnic communities and particularly the minority groups confront with variety of problems and challenges in the context of their development and quality of life. Therefore, the North Eastern Council, Govt. of India has assigned to the institute a study to provide an in-depth mapping of the minority ethnic communities in the region and identify certain key socio economic issues which might require certain development interventions. The study, therefore, intends to comprehend the problems and development deficits of the minority ethnic groups in the Northeast. The study therefore will make an attempt to map the minority ethnic communities in each state of the Northeast and create a socio-economic profile of the identified communities. In addition, the study will seek to understand the status of development/development deficits of the select/identified minority ethnic groups in the Northeast and identify the causes responsible for their deprivation, if any. Finally, the study envisaged to development/policy intervention in addressing the identified problems of the minority ethnic groups in each state of the Northeast. The study intends to come up with some broad policy options for the minority ethnic groups in the region.

The Government of Assam constituted the Assam Building and Other Construction Workers' Welfare Board in 2008. Under this board, the Govt. of Assam initiated the Skill Training Programme (STP) since the year 2018-19 in two phases covering the districts of Barpeta, Nalbari, Baksa, Bongaigaon, Darrang, Kamrup, Dibrugarh, Tinsukia, Dhemaji, Sivasagar and, Jorhat. Three agencies were engaged for the purpose. A total of 30 districts are covered under the Programme with 99 centres utilised by 13 Training Partners selected for the purpose. The Assam Building and Other Construction Workers' Welfare Board requested the responsibility on OKD Institute of Social Change & Development, Guwahati to assess the learning outcome of STP for the trained construction workers. The Institute, has taken up an impact assessment study on the outcomes of STP in eleven districts of Assam. This study mainly focuses on identification of exclusion or wrong inclusion in the beneficiary selection; assess the beneficiary satisfaction, effectiveness of Training partners, impact of STP upon the overall growth of the beneficiaries.

Workshop on Livelihood Vulnerabilities and Changing Agricultural pattern in Flood and Erosion prone districts of Lakhimpur and Dhemaji

A workshop was organized in collaboration with Dhakuakhana College at Dhakuakhana on 28th April, 2022 on “Issues on Livelihood Vulnerabilities and Changing Agricultural Pattern in the Flood and Erosion Prone Districts of Lakhimpur and Dhemaji”. The idea of the workshop was to understand the issues and vulnerabilities of flood and erosion affected areas in districts of Lakhimpur and Dhemaji. The workshop was attended by around 30 participants including 10 resource persons from local communities of both the districts who are well acquainted with the local situations and working on different areas for promoting alternative livelihood and agricultural practices. The event was coordinated by Dr. Akshay Jyoti Sarma of OKD Institute and Dr. Pankaj Borah of Dhakuakhana College.

National Seminar on Quest for Alternative Livelihood Measures in Flood-Affected Areas with Special Reference to Majuli

OKD Institute of Social Change and Development in collaboration with IQAC, Majuli College has organised a National Seminar on Quest for Alternative Livelihood Measures in Flood-Affected Areas with Special Reference to Majuli on 30th September, 2022 at Keshabram Borah Auditorium, Majuli College. Prof. Sailajananda Saikia of Rajiv Gandhi University delivered the key note address of the inaugural session of the seminar and subsequently two technical sessions were conducted where scholars from different colleges in the region presented their paper. The papers highlighted about indigenous alternative livelihood strategies especially of Mishing tribes, local adaptation and coping strategies of farmers to mitigate disasters, educational and economic status of flood affected people, etc.

National Seminar on Forest Rights, Administration and Challenges in Assam

Two-day national seminar was organised by DCB Girls’ College in collaboration OKD Institute of Social Change and Development, Guwahati on 29th & 30th November, 2022. Prof. Bhupen Sarma from OKDISCD delivered the key note address in the inaugural session of the seminar. The research scholars and academician from across the state have presented their paper. The scope of the seminar is to understand the forest rights in the context of Assam such as relation of forest to community spaces in Assam, role of the state in maintaining forest cover, rights of the indigenous communities, and challenges of deforestation, encroachment and eviction. The seminar had four technical sessions with 19 papers.

Panel Discussion during 23rd North East Economic Association Conference

The OKD Institute of Social Change and Development collaborated with the Economics Department of Tripura University to organize a panel discussion on 17th November, 2022 titled “India and her Neighbouring Countries” at the North East Economic Association conference held at Tripura University during 16th to 18th November 2022. Prof. Prabir De, ASEAN Centre, RIS New Delhi; Prof. B Panda, NEHU & Hony Director, ICSSR-NERC;

Interaction with Kerala Administrative Service Trainee Officers

On 27th of October, 2022, 21 newly selected State Civil Service training officers of Kerala and a guide came to visit Omeo Kumar Das Institute of Social Change and Development for their training purposes in the North Eastern region. The programme started with an introductory session followed by felicitation of the guests. Saswati Choudhury, Director (i/c) OKDISCD made a brief presentation about the Institute and its objectives and functions. She also provided the KAS training officers with insightful information about the history, culture and geographic attributes of North East India. The cadres gave a vivid description of decentralization system that exists in Kerala and how the Civil Society plays an important role in dealing with the various issues and challenges. They also threw light on the importance of Kudumbashree in Kerala. The program concluded with a vote of thanks offered by the guests.

Workshop on Qualitative Research Methodology

A workshop was held between 12 March to 18 March, 2023 at the Omeo Kumar Das Institute of Social Change and Development (OKDISCD). The purpose of the workshop was to share provide an indepth understanding to young social science researchers about different facets of Qualitative Research.
