1. A Master's Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed) in any of the disciplines as mentioned above from an Indian University, or an equivalent degree from an accredited foreign University.

The candidate must have a Ph.D. degree in the concerned/relevant discipline and a minimum of ten years of research experience at National Level Institutions working as Assistant Professor/Associate Professor/Professor, or teaching and research experience at equivalent level as Assistant Professor/Associate Professor/Professor at University/College with evidence of having successfully guided doctoral candidate.

- The Research score for research papers would be augmented as follows: Peer-Reviewed or UGC-listed Journals (Impact factor to be determined as per Thomson Reuter's list):
 - Paper in refereed journals without impact factor - 5 Points
 - Paper with impact factor less than 1 10 Points
 - Paper with impact factor between 1 and 2 15 Points
 - Paper with impact factor between 2 and 5 20 Points
 - Paper with impact factor between 5 and 10 25 Points
 - Paper with impact factor >10 30 Points
- The Research score for research papers would be augmented as follows:
- Two authors: 70% of total value of publication for each author.
- More than two authors: 70% of total value of publication for the First/Principal/Corresponding author and 30% of total value of publication for each of the joint authors.
- Joint Projects: Principal Investigator and Co-investigator would get 50% each.
- Paper presented if part of edited book or proceeding then it can be claimed only once.
- For joint supervision of research students, the formula shall be 70% of the total score for Supervisor and Cosupervisor. Supervisor and Co-supervisor, both shall get 7 marks each.
- For the purpose of calculating research score of the applicant, the combined research score from the categories of 5(ii)-Policy Document and 6- Invited lectures/Resource Person/Paper presentation shall have an upper capping of thirty percent of the total research score of the applicant concerned. The research score shall be from the minimum of three categories out of six categories.
